According to the **Turkish Personal Data Protection Law no. 6698** (hereinafter "the Law"), Article 11, personal data owners have the following rights:

- a) To know if your personal data is processed or not,
- b) If your personal data has been processed, to request information in this regard,
- c) To know the purpose of processing of your personal data and whether or not such has been used for its intended purpose,
- d) To know the identities of the domestic or foreign third parties to which your personal data has been transferred,
- e) To request the correction of your personal data in case of incomplete or inaccurate data, to request this correction to be communicated to third persons to which such personal data has been transferred in the first place,
- **f**) Although it has been processed in accordance with the provisions of the Law and other relevant laws, to request the deletion or destruction of the personal data in accordance with the Article 7 of the Law and to request that this action to be communicated to third persons to which such personal data has been transferred
- **g**) To object to the occurrence of a result which is detrimental to the person concerned as a result of analyzing the processed data exclusively through automatic systems
- **h**) To request compensation for any loss suffered by you in case your personal data is processed in violation of the relevant legislation.

According to the Article 13 Clause 1 of the Law you may submit the related requests by using this form and one of the 3 methods described below:
